## Pierce County Fire District 23 Board of Commissioners' Regular Meeting January 11, 2021

The board of Commissioners of Pierce County Fire District 23 met at 7 p.m., Monday, January 11, 2021 by Zoom. Those present included Chairman William Tylor, Commissioner Joe Koehler, Chief Matt Medford and District Secretary Nancy Adams. Commissioner Claudia Frey was absent.

Comm. Tylor asked if Comm. Koehler wanted to be chairman. Commissioner Koehler declined the honor, and Commissioner Tylor said he would do it for another year. Minutes of the December meeting were approved as written.

## Chief's Report January 2021

## General:

- January has continued with heavy call volume. We were one call away from tying the record. Call volume for the month was averaging 1.06 calls per day.
- Lucas device was deployed on it's first call and was extremely successful for the call that started with just two people. A "force multiplier" that allowed responders to not have to do compressions, allowing advanced measures to be conducted. Very thankful to have that device available. Should really look into a second device for the West end of the district based on limited staffing.
- Covid vaccine update: all members who elected to get shots have gotten second shots in January.
- FF1 Evaluation in Buckley, we provided 3 evaluators and two helpers assisted.
- Assisted Mount Rainier NP with SAR operations- Deputy IC position.
- Power and Phone outage due to Fiber cut near Thrift. Firstnet phones remained operational due to the satellite feed. Verizon and residential telephone service was down for about 20 hours. This service has been doing well for the district.
