Pierce County Fire District 23 Board of Commissioners' Regular Meeting April 10, 2023

The Board of Commissioners of Pierce County Fire District 23 met by Zoom at 7 p.m., Monday, April 10, 2023. Those present included Chairman Claudia Frey, Commissioners Joe Koehler and Caleb Young, Chief Matt Medford and District Secretary Nancy Adams. Minutes of the March meeting were approved as written.

With the secretary's report, Resolution 23-004 was approved. Signatures would come by commissioners later in the week. The secretary also gave the financial report listing cash and hand and investments. The chief read his report.

Comm. Young asked if there was an update on the chief's new vehicle. Chief Medford said hopefully, he would hear something soon. Comm. Young asked what the district would do with the old rig. Chief said the district might keep it longer for a shuttle rig, sell it or just cannibalize it and get rid of it.

Under old business, the secretary went over the meeting with Pierce County Budget and Finance. She said that the county would support the district in its choice regarding the issuance of their own warrants. She also went over the meeting with the Springbrook company that produces the BIAS software accounting program. The use of Quickbooks was discussed, but the secretary and chairman felt more comfortable with BIAS. The chief said he felt more comfortable with BIAS because it was a program that was well-known throughout the county, and if for some reason the secretary was dead, disabled or injured, he could go to other districts for help. After some discussion, the board approved the purchase of the BIAS software.

The chief told the board that he intends to have one or two electricians do a walk-through at Station 85 to do assessments for some repairs and upgrades. The board agreed.Comm. Koehler said he saw that an in-house announcement for hiring another firefighter and EMT went out. Chief Medford said he would see who responded.

The vouchers for the month were approved as presented. The meeting was adjourned at 7:37 p.m.
